ORDER

(Issued under Section 19 of the Right to Information Act,2005)

The appellant submitted an application dated 10-11-2020, under Section 6 of the Right to Information Act, 2005, (hereafter "the Act") to the respondent and sought for certain information. The respondent on 13-11-2020 transferred a part of the information sought to the PIO, Pondicherry Co-operative Milk Producers' Union Ltd., No. P.1 and to the PIO, Anandapuram CMPS Ltd.No. P.438 for furnishing the information directly to the appellant. The respondent furnished his reply on 30-11-2020 pertaining to his ambit.

2. Aggrieved by the respondent's response, stating that the required information not submitted, the appellant filed this first appeal dated 28-12-2020.

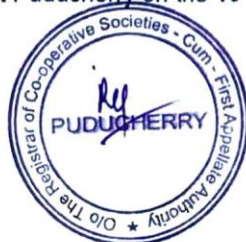
3. The response of the respondent was called for. The respondent furnished his response vide letter dt.08-02-2021 (**Copy forwarded to the Appellant**). On perusal of the said response, it is ascertained that the respondent on 13-11-2020 transferred a part of the information sought to the PIO, Pondicherry Co-operative Milk Producers' Union Ltd., No. P.1 (**Sl.No. 10 &29**) and to the Anandapuram CMPS Ltd.No. P.438 (**1,2,3,13,14,19,24 to 26,30,32,34 &35**) for furnishing the information directly to the appellant. Further, on 13-11-2020 the respondent informed the appellant to get information directly from the society concerned in respect of **Sl. No. 27 & 28**. The respondent furnished the available information in his ambit for the Sl.Nos. **4 to 9, 11,12,15 to 18, 20 to 23, 31 &33** to the appellant on 30-11-2020, well within the statutory time limit. It is also found that, the appellant preferred this appeal without any substantial grounds and with unclear evidence.

4. In view of the above , as nothing survives in this appeal, this first appeal is dismissed for lack of merits.

5. If aggrieved by this decision, a 2nd Appeal may be filed, under Section 19(3) of the Act, within 90 days, with the 2nd Appellate Authority, whose address is given below:
