ORDER:

Sanction of the Lieutenant Governor is conveyed for the release of ₹ 215.00 lakhs (Rupees Two hundred and fifteen lakhs only) towards share capital contribution of ₹ 60.00 lakhs and Grants-in-aid of ₹ 155.00 lakhs to the Housing Cooperatives as detailed in the annexure.

2. Necessary share certificate for the funds released should be furnished to the Directorate of Accounts and Treasures as per Rules.

3. The release of assistance should not exceed the authorized share capital contribution wherever the share capital assistance provided.

4. A fair dividend on the share capital contribution should be remitted to Government.

5. The grant is for recurring / non-recurring expenditure and is subject to the following conditions:

- (a). The grants shall be utilized in a time bound manner
- (b). The unspent balance of the previous grant has been taken into account
- (c). The Society shall get its accounts audited by chartered accounts / Departmental auditors.
- (d). The accounts of the society shall be opened for inspection by the sanctioning authority and audit by the Directorate of Accounts and Account General.
- (e). The society shall maintain subsidiary accounts of the Government grants as required under G.F.R 210.
- (f). The interest rebate is in accordance with the rules / guidelines issued vide Government Order 2nd cited.
- (g). A certificate of actual utilization shall be furnished in accordance with G.F.R. 212 (1).
- (h). Annual Reports of the Society shall be submitted to the Government.
- (i). The annual accounts of the grant receiving of society / institution should be completed within one month of the end of the financial year.

6. Certified that the pattern of assistance is in accordance with Plan Scheme duly approved by the Planning and Research Department, Puducherry.
