ORDER:

Sanction of the Lieutenant Governor is hereby accorded for release of ₹ 88.97 lakhs (Rupees Eighty eight lakhs and ninety seven thousand only) as III installment of grants-in-aid to the Pondicherry Cooperative Sugar Mills Ltd., for the year 2014-15 to make part payment of cane price to the cane growers.

2. The release of grants-in-aid is subject to the following conditions:
 - a. The grant shall be utilized in a time bound manner.
 - b. The society shall get its accounts audited by Chartered Accountants/ Departmental Auditors as the case may be and the audited statement of financial accounts shall be submitted to Government before closure of the next financial year as per GFR 212.
 - c. The accounts of the mills shall be open to inspection by the sanctioning authority and audit by the Director of Accounts & Treasuries and Accountant General.
 - d. The society shall maintain grants accounts of the Government as required under GFR 210.
 - e. Annual report of the mills shall be submitted to the Government.
 - f. The annual accounts of the grant receiving mills should be completed within six month of the end of the financial year.
 - g. The amount shall be deposited into the CCL A/c maintained by Pondicherry Cooperative Sugar Mills Ltd., with Pondicherry State Cooperative Bank Ltd., and that account operated to avail cash credit as per rules.
 - h. The amount shall not be used for any other purpose.
3. Certified that the pattern of assistance is in accordance with Plan Scheme duly approved by the Planning and Research Department, Puducherry.
