ORDER:

2. The release of grants-in-aid is subject to the following conditions:

- (a). (i) The society shall get its accounts audited by Chartered Accountants/Departmental Auditors, as the case may be and the audited statements of financial accounts shall be submitted to Government before closure of the next financial year as per GFR 212.
- (ii) The Department shall chalk out an action plan to complete upto date audit of the Cooperative Societies and ensure that the audit is conducted within the stipulated time.
- (b). The accounts of the society shall be open to inspection by the sanctioning authority and audit by the Director of Accounts & Treasuries and Accountant General.
- (c). The society shall maintain subsidy accounts of the Government as required under GFR 210.
- (d). A certificate of actual utilization shall be furnished in accordance with G.F. R. 212 (1) in the format GFR 19-A.
- (e). Interest accrued from Bank Accounts should be remitted into Govt. Account under the Head of account "0049 - Interest Receipts -04- Interest Receipts of State/UT Governments – 110 – Interest realized on Investment of cash balances" at the end of the financial year concerned.
- (f). Annual report of the society shall be submitted to the Government.
- (g). The annual accounts of the grant receiving society should be completed within one month of the end of the financial year.
