ORDER

Sanction of Lt. Governor is hereby accorded for incurring an expenditure not exceeding Rs.75,00,000/- (Rupees seventy five lakhs only) in the form of grant-in-aid under the scheme "Training and capacity building, Development of Human Resources, Publicity and propaganda, Monitoring and Evaluation" towards reimbursement of staff cost.

2. This grant is for recurring / non- recurring expenditure and is subject to the following conditions:

- a) The grants shall be utilized in a time bound manner.
- b) The unspent balance of the previous grants has been taken into account.
- c) The society shall get its accounts audited from Chartered accountants / Departmental auditors.
- d) The Accounts of the society shall be open to Inspection of the sanctioning authority and audit by the Directorate of Accounts and Accountant General.
- e) A certificate of actual utilization shall be furnished in accordance with G.F.R.212
- f) The annual accounts of grant receiving society should be completed within six months of the end of the financial year.

3. Certified that the pattern of assistance is in accordance with Plan Scheme approved by the Planning & Research Department.

4. The expenditure is debitable to the Head of account " 2425 - Cooperation - 277 Cooperative Education 277(01) - Assistance to Pondicherry State Cooperative Union for Cooperative Education programme 277(01)(01) - Puducherry Region (36) - Grant-in-aid - Salaries (Plan) in the budget of the current financial year .
