ORDER:

Sanction of the Lieutenant Governor is hereby accorded to the release of an amount not exceeding Rs.2,00,00,000 lakhs (Rupees two crore only) towards financial assistance in the form of Grants-in-Aid under the scheme " Investment Assistance to Dairy Cooperatives for business expansion, new business activities and better performances" to the Pondicherry Cooperative Milk Producers Union for the supply of cattle feed at 75% subsidy to the Milk pouring members of Milk cooperative societies in Union Territory of Puducherry. The amount shall be deposited in the Corpus Fund account maintained for this purpose.

2. The release of Grant-in-aid is subject to the following conditions:-

- i) The grant shall be utilized in a time bound manner.
- ii) The unspent balance of the previous grant has been taken into account.
- iii) The Society shall get its accounts audited from Chartered Accountants/ Departmental Auditors.
- iv) The accounts of the society shall be open to inspection by the sanctioning Authority and audit by the Director of Accounts and Accountant General.
- v) The society shall maintain subsidiary accounts of the Government grants as required under GFR 210 of GFR 2005.
- vi) A certificate of actual utilization shall be furnished in accordance with Rule 212(1) of GFR 2005.
- vii) Annual Reports of the society shall be submitted to the Government
- viii) The annual accounts of the grant receiving society should be completed within six months of the end of the financial year.
- ix) The pattern of assistance should be in accordance with the guidelines of G.O.Ms.No.3, dated 03/12/2013 of Chief Secretariat (Cooperation) and G.O.Ms.No.37/Coop, dated 11/3/2015.
