#### ORDER:

Sanction of the Lieutenant Governor is accorded to the release of an amount not exceeding Rs.65,00,000/- (Rupees Sixty five lakhs only) towards of financial assistance in the form of additional Government share capital and Grants-in-aid under the scheme "Investment Assistance to Dairy Cooperatives for business expansion, new business activities and better performances" to the Karaikal Co-operative Milk Producers' Union Ltd. and Primary Co-operative Milk Producers Societies in Karaikal region as detailed below.

#### 2. The sanction is subject to the following conditions:-

- Share certificate for the additional Government share capital contribution released should be furnished to the Director of Accounts and Treasures as per rules.
- The release of share capital assistance should not exceed the authorized share capital of the concerned society.
- A fair rate of dividend on the share capital contribution should be remitted to Government.
- The grant shall be utilized in a time bound manner.
- The unspent balance of the previous grant has been taken into account.
- The Society shall get its accounts audited for year upto 2014-15 from Chartered Accountants / Departmental Auditors, to qualify for financial assistance (Grants-in-aid /share capital) in the next year.
- The accounts of the society shall be open to inspection by the sanctioning Authority and audit by the Director of Accounts and Treasures and Accountant General.
- The society shall maintain subsidiary accounts of the Government grants as required under Rule 210 of GFR 2005.
- A certificate of actual utilization shall be furnished in accordance with Rule 212 (1) GFR 2005.
- Annual Reports of the society shall be submitted to the Government.
- The annual accounts of the grant receiving society should be completed within six months of the end of the financial year.

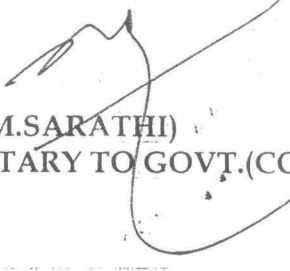
