ORDER:

The Co-operative Department Employees Association have raised demands for reviewing the cadre posts in respect of pay scales, re-structuring of posts and methods of recruitment. The demands have been examined carefully with reference to the recommendations of the Central Pay Commission in para 104.73 of their report, by the Registrar of Cooperative Societies. The Fifth Pay Commission has stated, that, "We recommended that a cadre review of this department may be carried out at the earliest. We also recommend that the designation of the post of Senior Inspector and Junior Inspector in the department may be changed to Inspector and Sub-Inspector."

2. The proposal, for cadre re-structuring which has been received from the Registrar of Cooperative Societies, Pondicherry, has been examined in consultation with the Department of Personnel and Administrative Reforms (Personnel Wing) and the Finance Department, Pondicherry.

3. At present the cadre structure of the post in the Cooperative Department are not in pyramidal structure, which causes, stagnation in the grade of Senior Inspectors and Junior Inspector. In the G.O. referred above, creation of deputation reserve posts for each category of posts in the Cooperative Department have been ordered. In order to restructure the number of deputation reserve post in tune with the restructuring of the departmental posts, the following restructure of departmental and deputation reserve posts are ordered as indicated in the next page:
