ORDER:

The Registrar of Co-operative Societies, Puducherry has submitted a proposal for the sanction of Rs.167.93 Lakhs as Grants-in-aid/Subsidy to Consumer/Miscellaneous/Industrial Co-operatives for the year 2013-14.

2. Sanction of the Lieutenant Governor is hereby accorded for incurring of an expenditure not exceeding Rs.167.93 Lakhs (Rupees one hundred and sixty seven lakhs and ninety three thousand only) as Grants-in-aid/Subsidy to Consumer/Miscellaneous/Industrial Co-operatives for the year 2013-14 in Puducherry, Karaikal, Mahe and Yanam Regions as detailed below and the society-wise details are enclosed in the Annexure I -VIII.

3. The release of grant-in-aid is subject to the following conditions:

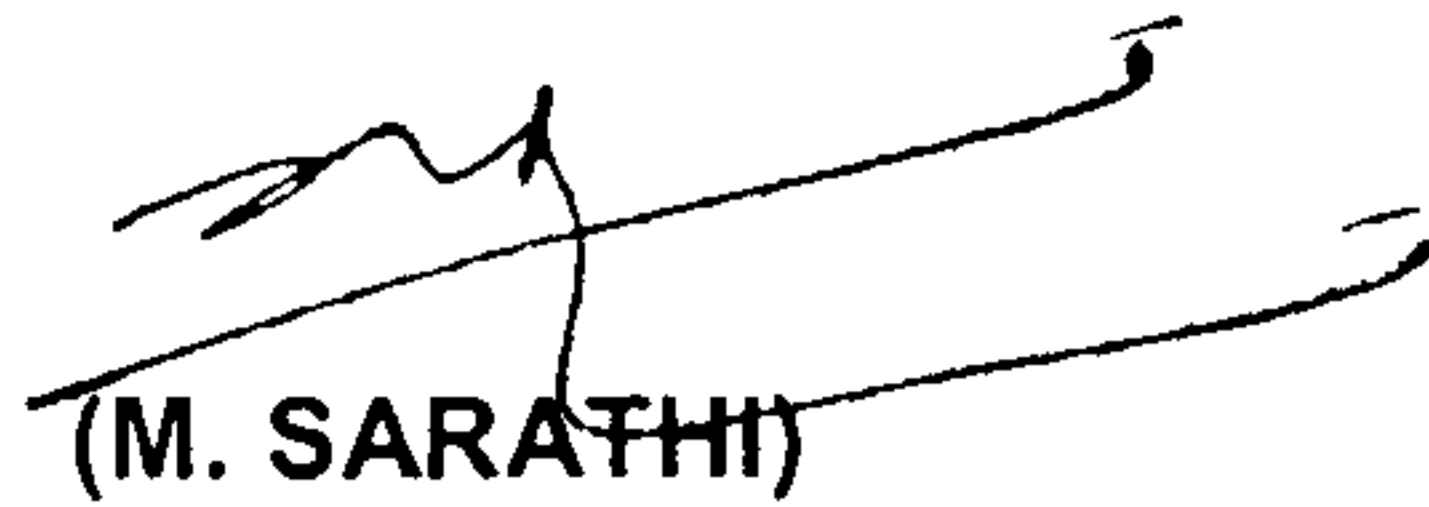
- a. The society shall get its accounts audited by Chartered Accountants/Departmental Auditors.
- b. The accounts of the society shall be open to inspection by the sanctioning authority and audit by the Directorate of Accounts & Treasuries and Accountant General.
- c. The society shall maintain subsidy accounts of the Government as required under GFR 210.
- d. A certificate of actual utilization shall be furnished in accordance with G.F. R. 212 (1) in the format GFR 19-A.
- e. Interest accrued from Bank Accounts should be remitted into Govt. Account under the Head of account "0049 - Interest Receipts -04- Interest Receipts of State/UT Governments – 110 – Interest realized on Investment of cash balances" at the end of the financial year concerned.
- f. Annual report of the society shall be submitted to the Government.
- g. The annual accounts of the grant receiving society should be completed within six month of the end of the financial year.
- h. The society shall maintain subsidiary accounts of the Government grants as required under GFR 150 (5).

4. Certified that the pattern of assistance is in accordance with Plan Scheme duly approved by the Planning Commission.

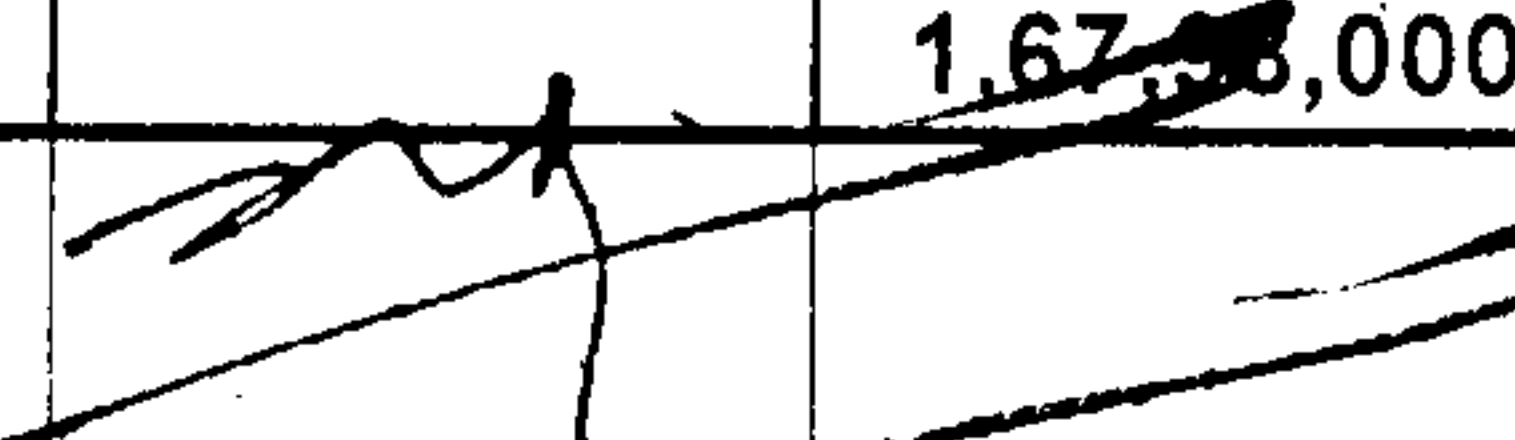
