ORDER

WHEREAS, the term of office of the committee of management of the Henkel SPIC Employees Co-operative Thrift and Credit Society Ltd., No.P. 586 expires on 31.3.2015;

AND WHEREAS, the committee has not conducted election to elect a new committee before expiry of its term of office;

AND WHEREAS, vide letter cited, the President of the society informed that most of the members of the society left the Henkel SPIC India Ltd., Karaikal and election could not be held. He requested to appoint an Administrator of the said society;

AND WHEREAS, in view of the above, I am of the opinion that an Administrator is to be appointed forthwith to manage the affairs of the society;

AND WHEREAS, I am satisfied that it is not reasonably practicable to publish a notice on the notice board of the society, inviting objection on the proposal of appointment of an Administrator, as alternative arrangements are to be made expeditiously;

AND WHEREAS, the financing bank, viz. the Pondicherry State Co-operative Bank Ltd was consulted in the matter of appointment of Administrator to the said society and the said bank has no objection to the proposal of appointment of Administrator;

NOW, THEREFORE, in exercise of the powers conferred on me under sub-section (1) of Section 33 of the Puducherry Co-operative Societies Act, 1972, I hereby appoint Thiru P. Savarirajalu, Junior Inspector, as Administrator of the Henkel SPIC Employees Co-operative Thrift and Credit Society Ltd., No.P. 586 with effect from 1.4.2015, in addition to his normal duties, till a new committee enters upon office.

The Administrator shall, subject to my control and to such instruction as I may give from time to time, have the power to exercise all or any powers of the committee and take all such action as may be required in the interest of the society.
