AND WHEREAS, the Pondicherry State Co-operative Bank has stated that it has no objection for the appointment of a liquidator for the said stores;

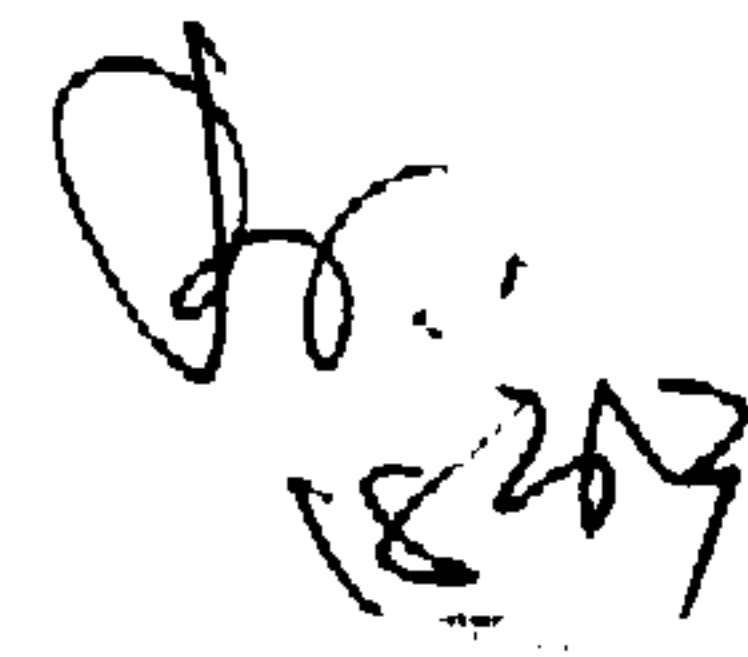
