ORDER:

WHEREAS, the Keezhoor Co-operative Milk Producers' Society Ltd. No. P.627 is a registered Co-operative Society under the Puducherry Co-operative Societies Act, 1972 and the rules made there under;

AND WHEREAS, it was brought to the notice of the undersigned that the said society was dormant for the past four years;

AND WHEREAS, in order to form an opinion for the purpose of deciding the further course of action an inspection under Section 76 of the Puducherry Co-operative Societies Act, 1972, was ordered;

AND WHEREAS, the Inspection report, inter-alia, reveals that the members of the society have not shown any interest to revive its activities due to the following reasons;

- a. Most of the members have sold their milch cow due to non-functioning of society.
- b. Sivaranthagam CMPS has started milk collection yard at Keezhoor, therefore they are willing to continue as yard member of Sivaranthagam CMPS.
- c. Moreover, the financial status of the society has not viable to meet the expenses viz staff salary, society rent and milk van freight charges etc.

AND WHEREAS, in view of the reasons stated above the undersigned formed an opinion that, there is no scope for the revival of the business of the society in future;

AND WHEREAS, in pursuance of sub-section(1) of Section 126 of the Puducherry Co-operative Societies Act, 1972, I gave an opportunity to the society to make its representation as to why the said society should not be wound up, vide notice read above;

AND WHEREAS, the Administrator of the said society, in his representation cited, has stated that the general body of the society at its meeting held on 29-11-2013 has already resolved to wind up the society and be stands by the decision;

AND WHEREAS, in view of the reasons adduced in pre-paras, I am of the opinion that the said society should be wound up;

NOW THEREFORE, in exercise of the powers conferred Under Section 126 of the Puducherry Co-operative Societies Act, 1972, I hereby direct winding up of the Keezhoor Co-operative Milk Producers' Society Ltd. No. P.627, with immediate effect and communicate the said order to the society.
