ORDER

WHEREAS the term of office of the committee of management of the Krishi
Vigyan Kendra Employees Co-operative Credit Society Ltd., No. P.602, will expire on
31.03.2018;

86 AND WHEREAS the President of the society, vide letter cited, stated that the
Parent institution viz. Perunthalaivar Kamaraj Krishi Vigyan Kendra, Puducherry had
not paid salary for last six months. This had resulted in default in repayment of dues for
more than three months by all members of the society. As a result all members are not
eligible voters and the prevailing situation is not conducive for conduct of election.
Hence, the society has sought permission for extension of term for a period of three
months from 01.04.2018 to 30.06.2018;

AND WHEREAS in view of the above, I am satisfied that the term of the existing
committee is to be extended;

NOW, THEREFORE, in exercise of the powers conferred on me under clause (b)
of sub-section (5) of Section 32 of Puducherry Co-operative Societies Act, 1972, read
with sub-rule (2) of Rule 41 of the Puducherry Co-operative Societies Rules, 1973,
I direct the term of office of the committee of management of the Krishi Vigyan Kendra
Employees Co-operative Credit Society Ltd., No.P. 602, be extended for a period of
three months, i.e., from 1st April 2018 to 30th June 2018.
