ORDER:

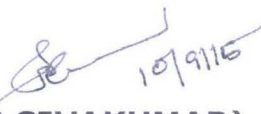
WHEREAS, an order was made, vide reference cited, under sub-section (1) of Section 126 of the Puducherry Co-operative Societies Act, 1972, directing the winding up of the affairs of the Sanniyasikuppam Co-operative Milk Producers' Society Ltd., No. P.560;

AND WHEREAS, to complete the winding up process of the said society, a liquidator is to be appointed under Section 127 of the Act;

AND WHEREAS, the financing Bank viz., the Pondicherry State Cooperative Bank was consulted in the matter of appointment of a liquidator, as required under sub-section (1) of Section 127 and the said bank has no objection for the appointment of Liquidator to the said milk society;

NOW THEREFORE, in exercise of the powers conferred on me under sub-section (1) of Section 127 of the Puducherry Co-operative Societies Act, 1972, I hereby appoint Thiru. R. Rangababu, Co-operative Officer, as the Liquidator, for the purpose of winding up of the said society.

Thiru. R. Rangababu, Liquidator shall take into his custody of all the properties, effects and actionable claims to which the society is or appears to be entitled and complete the liquidation proceedings as per law.
