under Rules 50 and 58 of the Puducherry Cooperative Societies Rules, 1973, approval
of the Registrar of Cooperative Societies is accorded to your society for the following:-

- a) Construction of two-storeyed office building at an estimated cost of
Rs. 1,29,66,000/- (Rupees One crore twenty nine lakhs sixty six thousand only).
- b) Floating of e-tender, through the Pondicherry State Cooperative Housing
Federation Ltd., No.P.486 (HOUSEFED), pertaining to the said construction
work.
- c) In pursuance of the reference cited and in exercise of the powers conferred
under **Rule 50** of the Rules, I am further directed by the Registrar to convey his
approval to utilize **Rs.33,92,901/-** (Rupees thirty three lakhs ninety two thousand
nine hundred and one only) from the accumulated "Building Fund" of the society
for construction of two-storeyed building for the society.
- d) In pursuance of the reference cited and in exercise of the powers conferred
under **Rule 58** of the Rules, I am also directed by the Registrar to convey his
approval to utilize **Rs.95,73,099/-** (Rupees ninety five lakhs seventy three
thousand and ninety nine only), from the "General Funds" of your society for
construction of two-storeyed building for the society
- e) Entrusting of construction supervision work and Payment of five per cent
(5%) of the cost of construction as supervision charges to HOUSEFED.
