2. The grant of financial up-gradation under the Modified Assured Career Progression Scheme shall be governed by the following terms and conditions.

- a) The Pay of the employee shall be fixed under the provisions of FR.22 (I) (a) (1) vide column (8) of the Table at pre-para.
- b) The employee shall be entitled to exercise option (exercisable within one month from the date of receipt of this order) to get the pay fixed in the higher Grade Pay either from the date of up-gradation or from the date of next increment.
- c) The financial benefit allowed under the Modified Assured Career Progression Scheme shall be final and no pay fixation benefit shall accrue at the time of regular promotion.
- d) Grant of higher Grade Pay under the MACP Scheme shall be conditional to the fact that an employee, while accepting the said benefit, shall be deemed to have given his un-qualified acceptance for regular promotion on occurrence of vacancy subsequently. In case, he refused to accept higher post on regular promotion subsequently he shall be subjected to normal debarment for the benefits under the scheme as communicated vide G. O. Ms. No. 84, dated 26.08.2009 of the Department of Personnel & Administrative Reforms (PW), Chief Secretariat, Puducherry.
- e) The grant of higher pay is subject to review by audit and if there is any over payment noticed at a later stage, the same will be recovered from the salary of the official
