In pursuance of the Memorandum cited under reference and on having reported for duty and after verifying all the original certificates & fulfillment of terms and conditions, Thiru. S. Karthikraj, S/o. S.T. Sambandan., No.199, Church street, Karaikal – 609 602 is appointed as Upper Division Clerk (Group C) in Pay Level-4 of the Pay Matrix (Pre-revised Scale of Pay of Rs.5200-20200 with Grade Pay of Rs.2400/-) on regular basis in the Co-operative Department, Puducherry with effect from the forenoon of 05th March 2024 vice Thiru. R. Rangaraj promoted.

2. The terms of appointment are as follows:-

- a) The appointment is temporary and may be terminated at any time by a month's notice given by either side without assigning any reasons. The Appointing Authority, however, reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to him of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof. Other conditions of Service will be governed by the relevant rules and orders in force from time to time.
- b) He is placed on probation for a period of two years with effect from 05.03.2024.
- c) He should also work as Cashier if he is so directed by the Head of Department/Office, for which he should furnish necessary Fidelity Bond/Cash Security.
- d) He should pass the prescribed departmental tests viz. Accounts Test for Subordinate Officers (Part-I & Part-II), Common General Departmental Test for Ministerial Staff during the period of probation failing which he will be ousted from service.

3. His pay is fixed @ Rs.25,500/- corresponding to Cell-1/Level-4 of Pay Matrix with effect from 05.03.2024 under Rule 8 & 10 of CCS (Revised) Pay Rules, 2016 along with other usual allowances at the rates admissible and subject to the conditions laid down in rules and orders governing the grant of such allowances in force from time to time.

4. He has produced necessary "Certificate of Fitness for Government Service" obtained from the Assistant Director (RMO), Indira Gandhi Government General Hospital and Post Graduate Institute, Puducherry vide No.24012, dated 05.03.2024.
