Sub: Co-operative Department – Dairy Section – Organization of new Women Co-operative Milk Producers' Society at Senthatham Village – Villianur Commune, Puducherry – Appointment of Chief Promoter – Ordered.

Read: 1. Representation dated 12.08.2020 received from the villagers of Senthatham, Puducherry.
2. The feasibility report dated 05.09.2020 received from the Managing Director, PCMPU., Puducherry.

The proposal to form a Co-operative Milk Producers Society in name and style of Senthatham Women Co-operative Milk Producers Society (proposed) was examined and the Registrar of Co-op.Societies is pleased to appoint Tmt.Gowari, W/o. Pakkri as Chief Promoter of the proposed “**Senthatham Women Co-operative Milk Producers' Society**”.

2. **Tmt. P.Gowari** is authorized to collect share suspense amount and entrance fees from the prospective members of the proposed milk society at the rate of Rs.100/- and Rs.5/- respectively and remit the same into the Pondicherry State Co-operative Bank, Villianur Branch under advance repayable account to be opened in the name of Senthatham Women Cooperative Milk Producers Society (Proposed). Printed cash receipt should be issued for all cash received on behalf of the proposed society.

3. She is also instructed to maintain proper account for receipt of money and expenditure incurred by her in connection with organization of the proposed society and keep them in order for inspection and audit at any time.

4. As soon as she collects share from atleast 25 persons, he should submit the roll of proposed members along with the prescribed application form in duplicate and five copies of the Bye-laws of the proposed society to this office for consideration of registration of the proposed Senthatham Women Co-operative Milk Producers' Society.

5. The Chief Promoter shall not carry on any business nor incur any liability on behalf of the proposed society.
