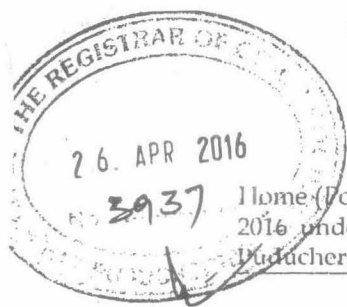

NOTIFICATION

In pursuance of the explanation to Section 25 of Negotiable Instruments Act, 1881 (Act XXVI of 1881) and the instructions issued by the Election Commission of India, the Lieutenant Governor, Puducherry is pleased to declare Monday the 16th May, 2016, a Public Holiday/Paid Holiday under Negotiable Instruments Act, 1881 for all Government Offices/Institutions/Local Bodies/Other Commercial Institutions located in the Union Territory of Puducherry in order to enable the Electors employed therein to exercise their franchise in the General Election to Puducherry Legislative Assembly, 2016.

2. This will be a Paid Holiday under Section 135 B of the Representation of the People Act, 1951 for the workers employed on daily wages in various Departments of this Administration.
