Subject: Co-operative Department – Consumers – The Puducherry Multipurpose Service Providers Co-operative Society Ltd. No. P.797 – Failure to constitute a new committee – Appointment of Administrator under Section 33 of the Puducherry Co-operative Societies Act, 1972 – Orders – Issued.

Read: Proceedings No.5/8/1/6/RCS/CONS/WS/2011/261 dt. 26-07-2011 of the Registrar of Co-op. Societies

ORDER:-

WHEREAS, the term of the existing Nominated Committee of Management of the Puducherry Multipurpose Service Providers Co-operative Society Ltd. No. P.797 expired on 27-07-2014.

2. **AND WHEREAS,** the said Committee of Management of the society not conducted election to elect a new committee of management of the society before expiry of the term of office in accordance with the provisions of Puducherry Co-operative Societies Act, Puducherry Co-operative Societies Rules and bye-laws of the society;

3. **AND WHEREAS,** in the above circumstances, I, the undersigned decided to appoint an Administrator to manage the affairs of the said society, under section 33(l)(a) of the Puducherry Co-operative Societies Act, 1972 till a new committee enters upon office;

4. **AND WHEREAS,** I, the undersigned satisfied that it is not reasonably practicable to publish a notice inviting objections to the above said proposal as required under the provision to sub-section (1) of section 33 of the Puducherry Co-operative Societies Act as an alternative arrangements to be made expeditiously;

5. **AND WHEREAS,** the financing Bank viz. The Pondicherry State Co-operative Bank Ltd. was also consulted on the matter of appointment of Administrator as contemplated in the Puducherry Co-operative Societies Act, 1972 and the Bank has expressed that it has "No objection" for the Appointment of Administrator to the said society.

6. **NOW THEREFORE**, in exercise of the powers conferred under sub-section (1)(a) of section 33 of the Puducherry Co-operative Societies Act, 1972, I, hereby appoint **Thiru. B. Vasanthakumar, Deputy Registrar, The Managing Director, Puducherry Multipurpose Service Providers Co-operative Society Ltd. No. P.797, Puducherry** also as the administrator on additional charge to manage the affairs of the Puducherry Multipurpose Service Providers Co-operative Society Ltd. No. P.797 with effect from 28-07-2014, in addition to his normal duties till a new elected committee enters upon office.

The Administrator shall be subject to the control of the Registrar and shall have power to exercise all or any of the functions of the committee or any officer of the society and take all such action as may be required in the interest of the society.

The Administrator shall conduct election within 3 months time from the date of assumption of charge as the Administrator.
