In partial modification of the reference cited and in exercise of the powers conferred under sub-section (4) of Section 83 of the Puducherry Co-operatives Societies Act., 1972 and Rule 42 of the Puducherry Co-operatives Societies Rules., 1973, the undersigned hereby revise the quantum of monthly remuneration, payable to the Officers / Officials, who are being appointed by the Government of Puducherry or the Registrar of Co-operative societies, as the case may be, to hold additional charges as Administrator and Managing Director of Pondicherry State Co-operative Housing Federation Ltd., No.P.486 as detailed below:-

Sl. No	Name of the Cooperative Institution	Monthly Honorarium Rs.
1	The Administrator, Pondicherry State Co-op. Housing Federation Ltd., No. P. 486	5,000/-
2	The Managing Director, Pondicherry State Co-op. Housing Federation Ltd., No.P.486	3,000/-

2. The above revision shall take retrospective effect from 01.07.2022 subject to the following:
- No honorarium is payable in respect of dormant societies, which didn't have business transactions for more than a year.
 - Revision of honorarium is applicable only if the society is financially viable.
 - No Officer /Official is entitled to receive remuneration from more than three (3) Coop. societies at a time.
 - No Officer /Official, who works in a coop. society on deputation basis, is entitled to receive honorarium from the society concerned even if he/she holds any post on additional charge basis in the same society.
 - No staffs of a coop. society, who holds any post additional charge basis/in-charge basis/ basis, is entitled to receive honorarium from the coop. society in which he/she works.
 - In the better interest of the coop. society, the Officers/Officials, who hold additional charges in coop. societies, may also give up their honorarium or may opt for lesser honorarium than permissible.
