ORDER:-

WHEREAS, the extended term of the existing Committee of Management of the Pondicherry Toy Makers Service Industrial Co-operative Society Ltd., No.P.427 expired on 31.12.2021.

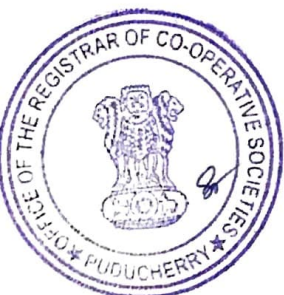
2. **AND WHEREAS**, the said Committee of Management of the society has not conducted election to elect a new committee of management of the society before expiry of the term of office in accordance with the provisions of Puducherry Co-operative Societies Act, Puducherry Co-operative Societies Rules and bye-laws of the society, and informed the same vide letter read above.

3. **AND WHEREAS**, in the above circumstances, the undersigned decided to appoint an Administrator to manage the affairs of the said society, under section 33(l)(a) of the Puducherry Co-operative Societies Act, 1972 till a new committee enters upon office;

4. **AND WHEREAS**, in pursuance of sub-section (1) of Section 33 of the said Act, the financing bank viz., Pondicherry State Co-operative Bank Ltd., was consulted and the said bank consented for the proposal of appointment of an Administrator;

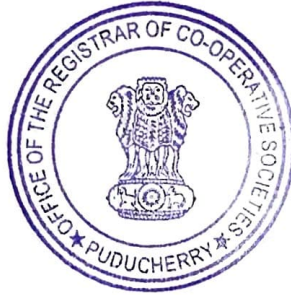
5. **AND WHEREAS**, I, the undersigned satisfied that it is not reasonably practicable to publish a notice inviting objections to the above said proposal as required under the provision to sub-section (1) of section 33 of the Puducherry Co-operative Societies Act as an alternative arrangements to be made expeditiously;

6. **NOW THEREFORE**, in exercise of the powers conferred under sub-section (1)(a) of section 33 of the Puducherry Co-operative Societies Act, 1972, the undersigned, hereby appoints **Thiru. A. Mamul Vasan, Senior Inspector** of this department, as the Administrator to manage the day to day affairs of the **Pondicherry Toy Makers Service Industrial Co-operative Society Ltd., No.P.427** with effect from 01.01.2022, in addition to her normal duties till a new committee enters upon office.

The Administrator shall subject to the control of the Registrar and shall have power to exercise all or any of the functions of the committee or any officer of the society and take all such action as may be required in the interest of the society.
