Read: Letter dated 24.11.2023 received from the Administrator of the Mother Theresa Anganwadi Employees Co-operative Credit Society Ltd., No.P.804 along with a copy of Resolution No. 5 dated 17.11.2023 of the General Body of the society.

ORDER:

In pursuance to the reference cited and in exercise of the powers conferred under sub-section (3) of section 11 of the Puducherry Co-operative Societies Act, 1972, read with Rule 7 of the Puducherry Co-operative Societies Rules, 1973, the Registrar of Co-operative Societies is pleased to register the amendment to bye-law No.32(i)and 32(ii) of the bye-laws of the **Mother Theresa Anganwadi Employees Co-operative Credit Society Ltd., No.P.804**, vide resolution cited and as detailed hereunder. The said amendment shall come into force from the date of issue of this proceedings.

32(i)	32. Constitution of Committee CONSTITUTION: The Executive management of the affairs of the society shall vest in a committee, consisting of nine (9) members, as detailed below:- I. Seven (7) members are to be elected by and from among the "A" Class members of the society. II. One (1) scheduled caste member is to be elected by and from among the "A" Class members of the society. III. One (1) member is to be elected by and from among the "B" class members of the society.	32 (i). Constitution of Committee CONSTITUTION: The Executive management of the affairs of the society shall vest in a board consisting of nine (9) members of which one (1) shall be earmarked for scheduled caste member, elected by and from among the 'A' class members from the following constituencies. Constituency - I Multi Purpose Worker Development Co-ordinator (MWDC) Five (5) of which one (1) shall be earmarked for SC member. Constituency - II - Four (4) members Multi Purpose Worker Development Helper (MWDH)
32(ii)	ELECTION OF OFFICE-BEARERS: After the "A" class members are elected by the general body, they shall elect from among themselves, a President, a Vice-President and a Treasurer, by the ballot in the manner prescribed in Rule 34 of the Rules, 1973.	32(ii) ELECTION OF OFFICE-BEARERS: After the committee members are elected by the general body, they shall elect from among themselves, a President, a Vice-President and a Treasurer, by the ballot in the manner prescribed in Rule 34 of the Rules, 1973.
