**ORDER:**

In partial modification of proceedings issued in the reference read above and in exercise of the powers conferred on me under sub-section (1) of the section 33 of the Puducherry Co-operative Societies Act, 1972, I hereby appoint a new committee consisting of the following three members to manage the affairs of the T.Palayam Primary Agricultural Co-operative Credit Society Ltd.,P.48 with immediate effect.

(i) Thiru. S.Sugathiya, M.No.1156

(ii) Thiru. L.Devanathan, M.No. 462

(iii) Thiru.R. Dharman, M.No.2095

2. Thiru. S.Sugathiya, M.No.1156 shall act as the President of the said committee. The Committee shall have power to exercise all or any of the functions of the committee subject to my control and to such directions as I may give from time to time under sub-section (2) of the said section and take all such action as may be required in the interest of the said society.

3. The Committee shall take expeditious steps to conduct election to the committee of management.

4. The three-men committee should not take any policy decision, which may affect the financial position of their society, without prior permission of the Registrar of Co-operative Societies.

5. The three-man committee should not engage or appoint any staff/remove any member of staff, without prior permission of the Registrar of Co-operative Societies.

6. The three-man committee should not either reinstate the staff member, who is under suspension, or place any one under suspension, without prior permission of the Registrar of Co-operative Societies.
