ORDER:

In partial modification of proceedings read above and in exercise of the powers conferred under section 33 (1) of the Puducherry Co-operative Societies Act, 1972. I hereby appoint a Committee consisting of the following three members to manage the affairs of Murungapakkam Primary Agricultural Co-operative Credit Society Ltd. P.64 vice Thiru. K.Maran, Administrator of the Society with immediate effect.

2. Thiru. S. Baskaran, M.No. 902 shall act as the President of the said committee. The Committee shall have power to exercise all or any of the functions of the committee subject to my control and to such directions as may give from time to time by the undersigned under sub-section (2) of the said section and take all such action as may be required in the interest of the said society.

3. The Committee shall take expeditious steps to hold election.

4. The Three Member Committee should not take any policy decision, which may affect the financial position of the society, without prior permission of the Registrar of Co-operative Societies.

5. The Three Member Committee should not engage or remove any staff, without prior permission of the Registrar of Co-operative Societies.

6. The Three Member Committee should not either reinstate the staff, who is under suspension, or place any one under suspension, without prior permission of the Registrar of Co-operative Societies.

7. The Three Member Committee should take steps to conduct General Body Meeting for democratic election within four months by updating the area of operation, finalizing of eligible voter list after deleting dead Voters, inclusion of new Voters etc., amendment of Bye-Laws by creating reservations as envisaged under the Puducherry Co-operative Societies Act, 1972 and Puducherry Co-operative Societies Rules, 1973 in respect of women reservation, reservation for the Scheduled Caste etc.,
