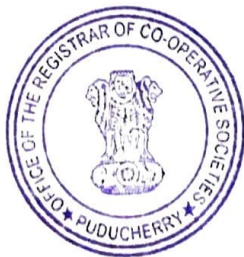
Read: This office show-cause notice No.5/8/1/6/RCS/CONS/MISC/2013/18, dated 07.02.2023.

ORDER:-

WHEREAS, a notice was issued vide reference cited, calling the Pondicherry Educational Co-operative Service Society Ltd., No.P.820 (**for brevity “the society”**), to state as to why the society should not be wound up under Section 126 (2) of the Puducherry Co-operative Societies Act, 1972 (**for brevity “the Act”**), as it is found that the society has not been functioning to fulfill the objects of the society since its inception. Moreover, the objects for which the society was registered has been found defeated.

2) **AND WHEREAS**, an opportunity was given to the societies, **vide reference cited**, to show-cause, within 15 days as to why their affairs shouldn't be wind up. But no reply is received till date;

3) **NOW, THEREFORE**, in view of the above and in exercise of the powers conferred under sub-section (2) of Section 126 of the Puducherry Co-operative Societies Act, 1972, I **hereby direct to winding up of the Pondicherry Educational Service Co-operative Society Ltd., No.P.820, Puducherry, forthwith and communicate this order to the said society.**
