PROCEEDINGS OF THE REGISTRAR OF COOPERATIVE SOCIETIES, PUDUCHERRY
(Issued under Section 33 of the Puducherry Cooperative Societies Act, 1972)

Sub: Karaikal Judicial Staff Co-operative Credit Society Ltd., No. P. 473 - Committee of management – Non conduct of election to the Committee of Management – Appointment of an Administrator under Section 33 of the Puducherry Co-operative Societies Act, 1972 – Order – Issued.

Read: RCS Proceedings No. No.RCS/Planning/Emp.Cr./Election corr./ 2026/69 dated 16.4.2026.

ORDER:

WHEREAS, the term of office of the elected committee of management (*for brevity "the committee"*) of Karaikal Judicial Staff Co-operative Credit Society Ltd., No. P. 473 (*for brevity "the society"*) expired on 31.03.2026;

2. AND WHEREAS, the term of the committee of management of the society was extended for a period of three months vide reference cited as the society was unable to conduct election to elect a new committee of management due to enforcement of Model Code of Conduct in connection with General Elections to Puducherry Assembly, 2026;

3. AND WHEREAS, the Committee of Management of the Society had neither taken steps to conduct elections to the Committee of Management nor submitted any proposal for further extension of the term of the Committee of Management;

4. AND WHEREAS, the Registrar is satisfied that a new committee cannot be constituted after the expiry of the term of office of the existing committee;

5. AND WHEREAS, in the circumstances stated above, the Registrar of Co-operative Societies is satisfied to appoint Administrator under sub-section (1) of the section 33 of the Puducherry Co-operative Societies Act, 1972 to manage the affairs of the said society till a new committee enters upon office;

6. AND WHEREAS, the Registrar of Co-operative Societies is also satisfied that it is not practicable to publish a notice inviting objections to the proposal for appointment of an Administrator to the said society as required under the first proviso to sub-section (1) of the section 33 as alternative arrangements is to be made expeditiously;

7. AND WHEREAS, the financing bank viz. Pondicherry State Co-operative Bank has been consulted in this regard and the said bank has no objection for appointing an Administrator to the said society;

8. NOW THEREFORE, in view of the above and in exercise of the powers conferred under sub-section (1) of the section 33 of the Puducherry Co-operative Societies Act, 1972 the Registrar of Co-operative Societies hereby appoints **Thiru. Y. Mohamed Farook, Junior Inspector**, Co-operative Department, Karaikal as the Administrator of the **Karaikal Judicial Staff Co-operative Credit Society Ltd., No. P. 473 with effect from 01.07.2026** in addition to his normal duties and instructed to conduct election to the committee of management within a period of six months.

9. The Administrator shall exercise all the functions of the said committee subject to the control of the undersigned and on such directions as may be given, from time to time, under sub-section (2) of the said section and take all such action as may be required in the interest of the said society.
