ORDER:

WHEREAS, Thiru.S. Meganathan, Senior Inspector, Co-operative Department was appointed as Administrator vide proceedings vide reference 1st cited for the Puducherry Pudumai Handicrafts Artisans Co-operative Society Ltd., No.P.652;

AND WHEREAS, a proceedings was issued for appointing Thiru.D. Ravishankar, Senior Inspector as administrator of the Puducherry Pudumai Handicrafts Artisans Co-operative Society Ltd., No.P.652 vice Thiru.S. Meganathan, Senior Inspector vide reference 2nd cited;

AND WHEREAS, in the mean time, members of the said society requested, vide reference 3rd cited, to appoint a three-member committee consisting the following members to manage the affairs of the said society. In view of the justification given, the undersigned satisfied to appoint the said committee;

NOW THEREFORE, in exercise of the powers conferred on the undersigned under Section 33 (1) (b) (i) of the Puducherry Co-operative Societies Act, 1972, **hereby appoint a three-member committee,** consisting of the following members, to manage the affairs of the **Puducherry Pudumai Handicrafts Artisans Co-operative Society Ltd., No.P.652,** Puducherry with immediate effect:

1. Thiru.R. Raju Silpi, M.No.1 - President
2. Thiru.K. Selvakumar, M.No.24 - Director
3. Thiru. A. Ramesh, M.No.135 - Director

Thiru. R. Raju Silpi, M.No.1 shall act as the President of the said committee. The committee shall have powers to exercise all or any of the functions of the committee or any affairs of the said society and to take all such action as may be required in the interest of the society, subject to the control of the undersigned with following instructions and to such instructions as may be given from time to time under Sub-Section (2) of the said Section.

- i) The three-member committee should arrange to complete election to the committee of management immediately;
- ii) The three-member committee should not take any policy decision which may affect the financial position of their society, without prior permission of the Registrar of Co-operative Societies;
- iii) The three-member committee should not engage or appoint any staff / remove any member of staff, without prior permission of the Registrar of Co-operative Societies;
- iv) The three-member committee should not either re-instate the staff, who is under suspension or place anyone under suspension, without prior permission of the Registrar of Co-operative Societies;

The three-member committee should invariably adhere the above said instructions, without any lapse. It may be noted that violation of the above said instructions, if any will be liable for legal action in accordance with law.
