**ORDER:**

In pursuance to the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Co-operative Society hereby permits the Pondicherry Cooperative Milk Producers' Union Employees' Cooperative Credit Society Ltd., No.P.374 to incur an expenditure of not exceeding **Rs.17,45,116/- (Rupees seventeen lakhs forty five thousand one hundred and sixteen only)**, from the general funds of the said society, towards the disbursement of interest rebate to **498 members** of the said society for the year 2022-23 , **through Electronic Clearing Service (ECS)**, as nine per cent (9%) rebate for the interest collected of Rs.1,93,90,227/- during the year 2022-23. The actual expenditure shall be charged in the accounting year 2022-23 itself and proper account shall be maintained for the disbursement of interest rebate.
