The said amendment shall come into force from the date of issue of this proceeding.

12(1)	Authorised Share Capital: The authorised share capital of the society shall be Rs.15,00,00,000/- (Rupees fifteen crores only) made up of 14,99,700 "A" class shares of Rs. 100/- each and 3,000 "B" class shares of Rs. 10/- each.	Authorised Share Capital: The authorised share capital of the society shall be Rs.18,00,00,000/- (Rupees eighteen crores only) made up of 17,99,700 "A" class shares of Rs. 100/- each and 3,000 "B" class shares of Rs. 10/- each.
