Sub: The Mother Theresa Anganwadi Employees Cooperative Credit Society Ltd., No.P.804 - Committee of Management –Extension of term under Section 32 of the Puducherry Cooperative Societies Act, 1972 – Order - Issued.

Read: Letter dated 06.03.2023 received from the President of the Mother Theresa Anganwadi Employees Cooperative Credit Society Ltd., No.P.804, along with copy of Resolution No.1 dated 16.05.2022 of the committee of management.

ORDER:

WHEREAS, the term of office of the elected committee of management (*for brevity "the committee"*) of the Mother Theresa Anganwadi Employees Cooperative Credit Society Ltd., No.P.804 (*for brevity "the society"*) expires on 31.3.2023;

2) AND WHEREAS, the present committee was elected on 16.03.2020 to hold the tenure for the period from 01.7.2020 to 31.3.2023;

3) AND WHEREAS, the President of the said society vide reference cited stated that more than 100 applications for admission to membership were pending for want of additional particulars and problem will arise if they are not enrolled as members before election. Moreover, the existing members agreed mutually to scrutinize and enroll the pending applications as members and conduct election;

4) AND WHEREAS, the President sought for extension of the committee for a period of three months commencing from 01.04.2023;

5) In view of the above, I am satisfied that, as requested by the committee, the term of office of the existing committee is to be extended for a period of three months;

6) **NOW, THEREFORE**, in exercise of the powers conferred on me under clause (b) of sub-section (5) of Section 32 of the Puducherry Cooperative Societies Act, 1972, read with sub-rule (2) of Rule 41 of the Puducherry Cooperative Societies Rules, 1973, **I extend the term of office of the existing committee of management** of the Mother Theresa Anganwadi Employees Cooperative Credit Society Ltd., No.P.804 **for a period of three months commencing from 01.04.2023;**
