WHEREAS, a three member committee was appointed to manage the affairs of the Kalapet Primary Agricultural Co-operative Credit Society Ltd. 2. AND WHEREAS, the said three member committee did not initiated any action for the conduct of election to constitute new committee of management as instructed;

3. AND WHEREAS, I am of the opinion that the condition stipulated in the proceedings 1st cited was not adhered by the three member committee;

4. NOW THEREFORE, in exercise of the powers conferred on me under sub section (1) of Section 33 of the Puducherry Co-operative Societies Act, 1972, I hereby appoint Tmt. B. Sumithra, Senior Inspector, Audit Section of this department as the Administrator of the Kalapet Primary Agricultural Co-operative Credit Society Ltd. No.P.96, with immediate effect in addition to her normal duties. The President of the three members committee of the society shall handover charges to the Administrator forthwith.

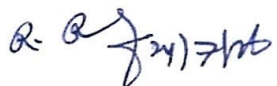
