WHEREAS, the term of office of the elected committee of management of the Puducherry Public Servants Co-operative Credit Society Ltd., No.P.52 **expired on 31.3.2025;**

2. AND WHEREAS, the existing committee of management has taken steps to conduct the election to the committee of management for the period from 1.4.2025 to 31.3.2028 and conducted election on **22.3.2025** and 12 directors were elected;
3. AND WHEREAS, the office bearer election was called on 29.3.2025 and the election was not conducted due to lack of quorum vide letter cited under reference and office bearers were not elected before the expiry of the existing term;
4. AND WHEREAS, the Registrar is satisfied that a new committee fails to enter upon office, on the date on which term of office of the existing committee expires;
5. AND WHEREAS, in the circumstances stated above, the Registrar of Co-operative Societies is satisfied to appoint Administrator under sub-section (1) of the section 33 of the Puducherry Co-operative Societies Act, 1972 to manage the affairs of the said society till a new committee enters upon office;
6. AND WHEREAS, the Registrar of Co-operative Societies is also satisfied that it is not practicable to publish a notice inviting objections to the proposal for appointment of an Administrator to the said society as required under the first proviso to sub-section (1) of the section 33 as alternative arrangements is to be made expeditiously;
7. AND WHEREAS, the financing bank viz. Pondicherry State Co-operative Bank has been consulted in this regard and the said bank has no objection for appointing an Administrator to the said society

8. NOW THEREFORE, in view of the above and in exercise of the powers conferred under sub-section (1) of the section 33 of the Puducherry Co-operative Societies Act, 1972, the Registrar of Co-operative Societies hereby appoints **Thiru. E. Gunasegaran, Co-operative Officer (Planning)**, Co-operative Department, Puducherry as the Administrator of the Puducherry Public Servants Co-operative Credit Society Ltd., No.P.52 **with effect from 01.04.2025** in addition to his normal duties and instructed to conduct election to the committee of management within six months.

9. The Administrator shall exercise all the functions of the said committee subject to the control of the undersigned and on such directions as may be given, from time to time, under sub-section (2) of the said section and take all such action as may be required in the interest of the said society.
