ORDER:

WHEREAS, Thiru.R.Indira Mogane, Senior Inspector, was appointed as the Administrator of the Kalmandapam Co-operative Milk Producers' Society Ltd., No.P.301, vide reference cited;

AND WHEREAS, the undersigned is satisfied that in order to bring a sense of democracy in the management, a three members committee is to be appointed in the said society;

NOW THEREFORE, in exercise of the powers conferred on to the undersigned under sub-section (1) of Section 33 of the Puducherry Co-operative Societies Act, 1972, the undersigned hereby appoint a three members committee consisting of the following members to manage the affairs of the Kalmandapam Co-operative Milk Producers' Society Ltd., No.P.301, with immediate effect, vice Thiru.R.Indira Mogane, Senior Inspector / Administrator.

Thiru. M.Adimoolam, S/o. Mannathan M.No.495 shall act as the President of the said committee. The committee shall have powers to exercise all or any of the functions of the committee or any officer of the said society and to take all such

action as may be required in the interest of the society, subject to the control of the undersigned with following instructions and to such instructions as may be given from time to time under sub section (2) of the said section.

- i. The three-member committee should arrange to complete election to the committee of management within six months from the date of assumption of charges;
- ii. The three-member committee should not take any policy decision, which may affect the financial position of their society, without prior permission of the Registrar of Co-operative Societies;
- iii. The three-member committee should not engage or appoint any staff / remove any member of staff, without prior permission of the Registrar of Co-operative Societies;
- iv. The three-member committee should not either re-instate the staff member, who is under suspension, or place any one under suspension, without prior permission of the Registrar;

The three-member committee should invariably adhere the above said instructions, without any lapses. It may be noted that violation of the above said instructions, if any will be liable for legal action in accordance with law.
