ORDER:

In partial modification of the order read above and in exercise of the powers conferred by sub-section (1) of Section 33 of the Puducherry Cooperative Societies Act, 1972, the undersigned is hereby appoint Tmt. J. Harani, Junior Inspector (Housing Section) as the Administrator of the Koodapakkam Co-operative Milk Producers' Society Ltd. No.P.289, with immediate effect in addition to her normal duties vice Thiru. D. Ravishankar, Deputy Registrar, (Housing In-charge).

2. The Administrator shall, subject to the control of the Registrar of Co-operative Societies and to such directions as he may give from time to time under sub-section (2) of Section 33 of the Act, and have power to exercises all or any of the functions of the committee or any officer of the said society and take all such actions as may be required in the interest of the society.

3. The Administrator shall, arrange to conduct election and to form a newly elected committee of management at the earliest.
