- Read:**1. Letter No. PECCOCSO/RCS/2025/72 dated 21.03.2025 received from the Election officer of the Pondicherry Engineering College Staff Co-operative Credit Society Ltd . No.P.647, Puducherry.
2. Letter No. PECCOCSO/RCS/2025/72 dated 24.03.2025 received from the President of the Pondicherry Engineering College Staff Co-operative Credit Society Ltd. No.P.647, Puducherry alongwith letter dated 24.3.2025 of the Election officer.
3. Letter dated 25.03.2025 received from the members of the Pondicherry Engineering College Staff Co-operative Credit Society Ltd., No.P.647, Puducherry.

WHEREAS, the term of office of the elected committee of management of **the Pondicherry Engineering College Staff Co-operative Credit Society Ltd., No.P.647 expired on 31.3.2025;**

2. AND WHEREAS, the existing committee of management has taken steps to conduct the election to the committee of management for the period from 1.4.2025 to 31.3.2028 and started election process from 19.3.2025 and the election officer Dr. R. Sridhar appointed by the society refused to conduct election as he got representation from the members regarding the eligibility for contesting in the election by the members who are got less than 3 years of service vide his letter dated 24.3.2025. The president of the society requesting to accept the request of the election officer and requested to extend the term of Committee of Management for a period of three months vide letter 2nd cited;
3. AND WHEREAS, a representation was received from 134 members of the society vide letter 3rd cited, to make an alternate arrangement to manage the affairs of the Society;
4. AND WHEREAS, the Registrar is satisfied that a new committee cannot be constituted after the expiry of the term of office of the existing committee;
5. AND WHEREAS, in the circumstances stated above, the Registrar of Co-operative Societies is satisfied to appoint Administrator under sub-section (1) of the section 33 of the Puducherry Co-operative Societies Act, 1972 to manage the affairs of the said society till a new committee enters upon office;

6. AND WHEREAS, the Registrar of Co-operative Societies is also satisfied that it is not practicable to publish a notice inviting objections to the proposal for appointment of an Administrator to the said society as required under the first proviso to sub-section (1) of the section 33 as alternative arrangements is to be made expeditiously;

7. AND WHEREAS, the financing bank viz. Pondicherry State Co-operative Bank has been consulted in this regard and the said bank has no objection for appointing an Administrator to the said society;

8. NOW THEREFORE, in view of the above and in exercise of the powers conferred under sub-section (1) of the section 33 of the Puducherry Co-operative Societies Act, 1972 the Registrar of Co-operative Societies hereby appoints **Thiru. K. Manavalan, Senior Inspector, Planning Section, Co-operative Department, Puducherry** as the Administrator of the **Pondicherry Engineering College Staff Co-operative Credit Society Ltd., No. 647 with effect from 01.04.2025** in addition to his normal duties and instructed to conduct election to the committee of management within six months.

9. The Administrator shall exercise all the functions of the said committee subject to the control of the undersigned and on such directions as may be given, from time to time, under sub-section (2) of the said section and take all such action as may be required in the interest of the said society.
