ORDER:

WHEREAS, the term of office of the elected committee of management of the following four (4) Staff & Employees' Cooperative Credit Societies expires on 30.06.2021:

2) **AND WHEREAS**, the committee of management of the societies have requested, *vide references 1st to 4th cited*, to extend their term for a period of three (3) months citing the COVID 19 Pandemic;

3) **AND WHEREAS**, in view of the above, I am satisfied that, the term of office of the committee of management of the societies are to be extended for a period of three months in as much as under the provisions of the Puducherry Cooperative Societies Act, 1972 and the Rules made thereunder, maximum period of extension of term of office of the committee of management of societies shall not exceed six (6) months in aggregate and three (3) months at any one time.

4) **NOW, THEREFORE**, on the above premises and due to COVID 19 Pandemic and in exercise of the powers conferred on me under clause (b) of sub-section (5) of Section 32 of the Puducherry Cooperative Societies Act, 1972, read with sub-rule (2) of Rule 41 of the Puducherry Cooperative Societies Rules, 1973, I extend the term of office of the existing elected committee of management of the above said four (4) Nos. of Employees' / Staff Cooperative Credit Societies for a period of three (3) months commencing from 01.07.2021.

5) **The committee of management of the said societies are directed to arrange to conduct their election, before the expiry of their extended term, to install a new committee with effect from 01.10.2021.**
