(Issued under Section 32 of the Puducherry Co-operative Societies Act, 1972)

Read: Letter dated 18-03-2024 received from the President of the Puducherry
Municipality Employees Co-operative Credit Society Ltd., No. P. 447,
along with copy of **Resolution No. 2** dated 18-03-2024 of the committee
of management.

ORDER:

WHEREAS, the term of office of the elected committee of management (*for brevity "the committee"*) of the Puducherry Municipality Co-operative Credit Society Ltd., No. P. 447 (*for brevity "the society"*) expires on 31-03-2024;

2) **AND WHEREAS**, the said committee issued an election notice dated 15-02-2024 to the members of the society, in respect of conduct of election to elect a new committee;

3) **AND WHEREAS**, based on the request from the society, Thiru. A. Irusappan, Senior Inspector was appointed as "Election Officer," vide proceedings dated 23-02-2024, to conduct the said election;

4) **AND WHEREAS**, as per the election schedule, the said Election Officer received nominations on 12-03-2024, scrutinized them on 13-03-2024 and published final list of eligible candidates on 14-03-2024. As per the election schedule, polling was scheduled on 20-03-2024;

5) **AND WHEREAS**, in the meantime, the Election Commission of India announced the schedule of General Elections to House of People, 2024 on 16-03-2024. As per the said announcement, polling will be held on 19-04-2024 for Puducherry Parliamentary Constituency;

6) **AND WHEREAS**, in view of the forthcoming general elections, 2024, the committee resolved, vide **Resolution cited**, to postpone the said polling scheduled on 20-03-2024 and all the election proceedings scheduled as per the said election notice;



7) **AND WHEREAS**, in accordance with the direction issued by this department vide circular no. RCS/Planning/Circular/2024 dated 18-03-2024 for the management and employees of the registered co-operative societies to observe the Model Code of Conduct (MCC), the committee requested, vide Resolution cited, to extend its term for a period of three months commencing from 01-04-2024;

8) **AND WHEREAS**, in view of the above, the Registrar of Co-operative Societies satisfied that, as requested by the committee, the term of office of the existing committee is to be extended for a period of three months.

9) **NOW, THEREFORE**, in exercise of the powers conferred under clause (b) of sub-section (5) of Section 32 of the Puducherry Cooperative Societies Act, 1972, read with sub-rule (2) of Rule 41 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Co-operative Societies hereby extends the term of office of the existing committee of management of the Puducherry Municipality Employees Co-operative Credit Society Ltd., No. P.447 for a period of three months from 01-04-2024 to 30-06-2024.

10) The committee of management is directed to arrange to conduct election to install a new committee **before** the expiry of its extended term and ensure that a new committee takes charges with effect from **01.07.2024**
