In pursuance to the reference cited and in exercise of the powers conferred on me under sub-section (3) of section 11 of the Puducherry Co-operative Societies Act, 1972, read with Rule 7 of the Puducherry Co-operative Societies Rules, 1973, I am pleased to register the amendment to **bye-law No.16 (i)** of the bye-laws of the **Krishi Vigyan Kendra Employees Co-op. Credit Society Ltd., No.P.602**, vide resolution cited and as detailed hereunder. **The said amendment shall come into force from the date of issue of this proceedings with a condition to follow the loan issue modalities properly by obtaining a guarantee from a permanent staff member in respect of FTCLR.**

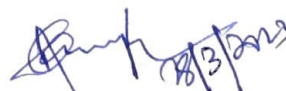
