ORDER:-

WHEREAS, the term of the existing Committee of Management of the Karaikal Women Co-operative Printing Society Ltd., No.P.348, Karaikal expires on 30.06.2026.

2. **AND WHEREAS**, the five members of the committee of management have been submitted their resignation letters to the President and subsequently the President of the said society has also submitted her resignation letter to the Deputy Registrar of Co-operative Societies, Karaikal. In this regard, the strength of members of the committee of management falls below the quorum and the committee can no longer function lawfully, it would mean that the committee has defunct;

3. **AND WHEREAS**, in this situation, the Deputy Registrar of Co-operative Societies, Karaikal has requested to appoint an Administrator to look after the day-to-day affairs of the society;

4. **AND WHEREAS**, in the above circumstances, the undersigned decided to appoint an Administrator to manage the affairs of the said society, under section 33(l)(a) of the Puducherry Co-operative Societies Act, 1972 till a new committee enters upon office;

5. **AND WHEREAS**, the undersigned satisfied that it is not reasonably practicable to publish a notice inviting objections to the above said proposal as required under the provision to sub-section (1) of section 33 of the Puducherry Co-operative Societies Act as an alternative arrangement to be made expeditiously;

6. **NOW THEREFORE**, in exercise of the powers conferred under sub-section (1)(a) of section 33 of the Puducherry Co-operative Societies Act, 1972, the undersigned, hereby appoints **Tmt. L. Sai Geetha Rani, Co-operative Officer, O/o. the Deputy Registrar of Co-operative Societies, Karaikal**, as the Administrator to manage the day-to-day affairs of the **Karaikal Women Co-operative Printing Society Ltd., No.P.348, Karaikal** with immediate effect, in addition to her normal duties till a new committee enters upon office.

The Administrator shall subject to the control of the Registrar have power to exercise all or any of the functions of the committee or any officer of the society and take all such action as may be required in the interest of the society.
