Bye-law No.	As Existing	As Amended
12 (1)	Authorised Share Capital: The authorised share capital of the society shall be Rs.15,00,00,000/- (Rupees fifteen crores only) made up of 14,00,000 shares of Rs.100/- each and 1,00,000/- "B" class share of Rs.100/- each.	Authorised Share Capital: The authorised share capital of the society shall be Rs.20,00,00,000/- (Rupees twenty crores only) made up of 19,00,000/- "A" class shares of Rs.100/- each and 1,00,000/- "B" class share of Rs.100/- each.
