ORDER:

WHEREAS, the term of office of the Committee of Management of the Puducherry Teachers Co-operative Housing Society Ltd., No. P.495 expires on 30.9.2024;

AND WHEREAS, the Committee of Management of the said society failed to conduct election to form a new committee before 30.9.2024;

AND WHEREAS, I am satisfied that a new committee cannot be constituted before the expiry of the term of office of the existing committee of management of the said society i.e 30.9.2024;

AND WHEREAS, in view of the above, I am of the opinion that an Administrator is to be appointed under Section 33 of the Puducherry Co-operative Societies Act, 1972 to manage the affairs of the said society till a new committee enters upon office;

AND WHEREAS, I am also satisfied that, it is not reasonably practicable to publish a notice, inviting objections for the proposed appointment of Administrator for the society as provided under proviso sub section (1) of section 33 of the Puducherry Co-operative Societies Act, 1972, as an alternative arrangement is to be made immediately;

NOW, THEREFORE, in view of the above and in exercise of the powers conferred on me under sub section (1) of section 33 of the Puducherry Co-operative Societies Act, 1972, I hereby appoint Thiru. P. Ramadjeame, Senior Inspector as Administrator of the Puducherry Teachers Co-operative Housing Society Ltd., No. P.495 with immediate effect in addition to his normal duties till a new committee enters upon office;

The Administrator shall exercise all the functions of the committee subject to my control and to such instructions, as I may give, from time to time, under sub-section (2) of the said section.
