ORDER:

In pursuance of the reference cited and in exercise of the powers conferred on me under **Rule 17** of the subsidiary regulations governing the sanction of **medium-term loan** to the members of the Hindustan Unilever Ltd., Employees Coop. Thrift & Credit Society Ltd., No.P.796, I am pleased to approve the amendment made to **Rule No.4** of the said regulations, vide resolution cited and as detailed hereunder. The said amendment shall come into force from the date of issue of this proceedings.

Subsidiary regulations governing the sanction of medium-term loan to the members		
Rule No.	As Existing	As Amended
4	<u>Limit of loan:</u> The maximum amount of loan that may be sanctioned to a member under these regulations shall not exceed twenty (20) times of his gross pay or Rs.2,00,000/- (Rupees two lakhs only), whichever is less. Provided that, no member shall be indebted to the society for a sum exceeding Rs.2,00,000/- (Rupees two lakhs only), at any time.	<u>Limit of loan:</u> The maximum amount of loan that may be sanctioned to a member under these regulations shall not exceed twenty (20) times of his gross pay or Rs.3,00,000/- (Rupees three lakhs only), whichever is less. Provided that, no member shall be indebted to the society for a sum exceeding Rs.3,25,000/- (Rupees three lakhs twenty-five thousand only) at any time.
