In pursuance of the reference cited and in exercise of the powers conferred on me under sub-section (3) of section 11 of the Puducherry Co-operative Societies Act, 1972, read with Rule 7 of the Puducherry Co-operative Societies Rules, 1973, I am pleased to register the amendment to bye-law No.12(1) of the bye-laws of the LIC Staff Cooperative Society Ltd., No.P.178, vide resolution cited and as detailed hereunder. The said amendment shall come into force from the date of issue of this proceedings.

Bye-law No.	As Existing	As Amended
12(1)	Authorised Share Capital: The authorised share capital of the society shall be Rs.10,00,000/- (Rupees ten lakhs only) made up of 1,00,000 shares of Rs. 10/- (Rupees ten only) each. There will be only one category of share.	Authorised Share Capital: The authorised share capital of the society shall be Rs.25,00,000/- (Rupees twenty five lakhs only) made up of 2,50,000 shares of Rs. 10/- (Rupees ten only) each. There will be only one category of share..
