ORDER:

2) The said Administrator shall, subject to the control and instructions, of the Registrar of Co-operative Societies, have power to exercise all or any of the functions of the committee of management or any officer of the said society and take all such actions as may be required in the interest of the said society.

3) The Administrator shall arrange to conduct election to form new Committee of Management of the above said society at the earliest.
