ORDER:

In pursuance of the reference cited and in exercise of the powers conferred under Rule 58 of the Puducherry Cooperative Societies Rules, 1973, the Registrar of Co-operative Societies hereby permits the **Yanam Public Servants Cooperative Society Ltd., No.P.55** to incur an expenditure of not exceeding **Rs. 6,89,584/- (Rupees six lakhs eighty nine thousand five hundred and eighty four only)**, from the general funds of the said society, towards disbursement of interest rebate to **196 Non-over due members only** for the year **2025-26**, through Electronic Clearing Service (ECS), as **11 % rebate** for the interest collected of **Rs.62,68,956/-** during the year **2025-26**.

2. The actual expenditure shall be charged in the accounting year **2025-26** itself and proper account shall be maintained for the disbursement of interest rebate. The interest rebate is allowed only for non-overdue members and action should be taken to recover the loan outstanding from the Overdue members.
