Read: Letter dated 10.05.2024 received from the President of the Puducherry Public Works Department Staff Cooperative Society Ltd., No.P.252 along with copy of Resolution No.4 dated 9.5.2024.

ORDER:

WHEREAS, the term of office of the elected committee of management (*for brevity "the committee"*) of the Puducherry Public Works Department Staff Cooperative Society Ltd., No.P.252 (*for brevity "the society"*) expires on **30.06.2024**;

2) AND WHEREAS, the President of the said society vide reference cited stated that it is unable to conduct election to the new committee of management for the period **1.7.2024 to 30.6.2027** due to enforcement of Model Code of Conduct in connection with the **General Election to Lok Sabha 2024** and in obedience to the RCS instruction vide RCS circular dated 18.3.2024;

3) AND WHEREAS, the President sought for extension of the committee for a period of three months commencing from 01.07.2024;

4) In view of the above, the Registrar of Co-operative Societies satisfied that, as requested by the committee, the term of office of the existing committee is to be extended for a period of three months;

5) NOW, THEREFORE, in exercise of the powers conferred under **clause (b) of sub-section (5) of Section 32** of the Puducherry Cooperative Societies Act, 1972, read with **sub-rule (2) of Rule 41** of the Puducherry Cooperative Societies Rules, 1973, **the Registrar of Co-operative Societies hereby extends the term of office of the existing committee of management of the Puducherry Public Works Department Staff Cooperative Society Ltd., No.P.252 for a period of three months commencing from 01.07.2024**;
