ORDER:

WHEREAS a Three Member Committee was appointed to Keezhsathamangalam Co-operative Milk Producers' Society Ltd., No.P.450 with following members to manage the affairs of the Society vide Proceedings cited above:

And Whereas, from among the Three Member Committee one Thiru.M.Ramasamy, M.No.97, President of the society has resigned his post;

And Whereas, due to his resignation the Three Member Committee gets dissolved as there is “No quorum” in the Three Member Committee.

AND WHEREAS, in view of the above, I am of the opinion that an Administrator is to be appointed under Section 33 of the Puducherry Cooperative Societies Act, 1972, to manage the affairs of the said society till a new committee enters upon office;

AND WHEREAS, I am satisfied that it is not reasonably practicable to publish a notice on the notice board, inviting objection to the above said proposal, as required under the first proviso to sub-section (1) of the said Section 33, as alternative arrangements are to be made expeditiously;

NOW THEREFORE, in exercise of the powers conferred on me under sub-section (1) of Section 33 of Puducherry Co-operative Societies Act, 1972, I hereby appoint **Thiru. R.Indira Mogane, Senior Inspector (Audit Section), Co-operative Department, Puducherry** as the Administrator of the Keezhsathamangalam Co-operative Milk Producers' Society Ltd., No.P.450, with immediate effect in addition to his normal duties, till a new committee enters upon office.

The Administrator shall exercise all the functions of the Committee, subject to my control and to such instructions, as I may give, from time to time, under sub-section (2) of the said section.

The Administrator shall arrange to conduct election early and to form a new Committee of Management as per sub-section (3) of said Section.
