AUTHORISED SHARE CAPITAL (i) the authorised share capital of the Society shall be Rs.10,00,00,000/- (Rupees ten crores only) made up of 9,95,000 "A" class shares of Rs.100/- each and 50,000 "B" class shares of Rs.10/- each.	12. AUTHORISED SHARE CAPITAL (i) the authorised share capital of the Society shall be Rs.15,00,00,000/- (Rupees fifteen crores only) made up of 14,95,000 "A" class shares of Rs.100/- each and 50,000 "B" class shares of Rs.10/- each.
