ORDER:

WHEREAS, election to the committee of management of the Puducherry Health Employees Cooperative Credit Society Ltd., No. P. 475 was conducted for the period from 01-09-2019 to 30-06-2021 and the eleven members viz. Tvl., O. Ganabathy, M. No. 2150, S. Karunakaran, M. No. 2722, RadhaMuthu, M. No. 2636, V. Arigaran, M. No. 2660 (S.C), R. Bakthavachalam, M. No. 2574, M. Gunasekaran, M. No. 2539, R. Ilendjeyene, M. No. 2478 (S.C), P. Prabakar, M. No. 2777, P. Saravanan, M. No. 3296, R. Vijayalakshmi, M. No. 3023 and S. Zamboukesan, M. No. 3970, were elected to the committee of the said society;

AND WHEREAS, Thiru. O. Ganapathy, M. No. 2150, President of the Society was expired on 23-02-2022, Thiru. R. Bakthavachalam, M. No. 2574 retired on superannuation on 31-01-2022, Tmt. R. Vijayalakshmi, M. No. 3023, Director resigned on 16-05-2022, Thiru. M. Gunasekaran, M. No. 2539 and Thiru. P. Saravanan, M. No. 3296 resigned from their Director posts on 17-05-2022;

AND WHEREAS, Thiru. S. Karunakaran, Vice-President called for a meeting circular dated 21-05-2022 to decide on the conduct of election, to review the resignations tendered by the two directors on 17-05-2022 and to approve the loan applications. But, the meeting could not be conducted for lack of quorum;

AND WHEREAS, it is evident that due to the resignation, retirement and death of the above said 5 Directors, the committee can no longer function as the effective strength has fallen from 11 to 6 numbers, which is below the quorum of seven members as prescribed under bye-law no. 32 (v) of the Bye-Laws of the said society;

AND WHEREAS, I am satisfied that it is not reasonably practicable to publish a notice on the notice board and invite objections;

AND WHEREAS, the financing bank namely, the Pondicherry State Co-operative Bank Ltd., has been consulted the matter of appointment of three-member committee to manage the affairs of the said society and the said bank have no objection to the said appointment;

NOW THEREFORE, in exercise of the powers conferred on me under sub-section 1 (b) (i) of Section 33 of the Puducherry Co-operative Societies Act, 1972, I hereby appoint a three-member committee consisting of the following members to manage the affairs of the Puducherry Health Employees Cooperative Credit Society Ltd., No. P. 475 with immediate effect,

Tvl./Tmt. :

1. M. Gunasekaran, M. No. 2539
2. P. Saravanan, M.No. 3296
3. G. Pravina, M.No. 2767

Thiru. M. Gunasekaran, M. No. 2539 shall act as the President of the said committee. The committee shall have powers to exercise all or any of the functions of the committee or any officer of the said society and to take all such action as may be required in the interest of the society, subject to the control of the undersigned with following instructions and to such instructions as may be given from time to time under sub section (2) of the said section.

- i. The three-member committee should arrange to complete election to the committee of management immediately from the date of issue of this proceedings;
- ii. The three-member committee should not take any policy decision, which may affect the financial position of their society, without prior permission of the Registrar of Cooperative Societies;
- iii. The three-member committee should not engage or appoint any staff / remove any member of staff, without prior permission of the Registrar of Co-operative Societies;
- iv. The three-member committee should not either re-instate the staff, who is under suspension or place anyone under suspension, without prior permission of the Registrar;

The three-member committee should invariably adhere the above said instructions, without any lapse. It may be noted that violation of the above said instructions, if any will be liable for legal action in accordance with law.
